PLANT 16 INTERVIEWS

During the week of August 22, 2011, interviews will be conducted for the initial openings for Assembler/Group Leader in the new Plt. 16 (old Plt. 7) area. Anyone with an active Plt. 16 Transfer Agreement application (submitted prior to Aug. 19th) on file for Assembler (and/or Assembler . Leader) will be eligible (by seniority) for interview. Those selected for interview will be contacted by their Supervisor or Hourly Personnel. It is anticipated that placement for these initial openings will take place in the mid to late Sept. 01 time frame. Remember, applications for openings in the new Plt. 16 plant are available through your Bargaining Reps or Supervisor.

ADDITIONAL PARKING RESTRICTIONS (Plt. 3 Admin – South)

Beginning Wednesday, August 3rd, designated parking spaces in the South Administration Building lot (south side of 10th St.) along the outer wall of Plt. 6 Central Shipping (approx. Bay C35 . C-49) will be temporarily restricted/eliminated, until the end of normal business hours on Friday, August 5th. The temporary restriction is due to equipment setup for roof repairs, and includes the row of parking spaces along the gravel apron nearest the building.

- 2011 **Ergonomic Safety Shoe vouchers** . Last day to redeem is September 11, 2011 and requires you to present your ATI plant ID and the printed voucher. You may visit any of the area Red Wing shoe stores, or look for the Aug./Sept shoe mobile scheduled to visit the plant.
